## Roles and Responsibilities

## SO is fully responsible for gate controlling on following aspects: -

- Labour entry at Gate (Main gate) All the labours should be above 18 years old and no labours to be allowed inside the factory with Dhoti and lunkies.
- All labours are to be in position of PPE's and all labours are to be in position of Helmet and shoes.
- All labours are to be checked (frisking) thoroughly while entering and leaving at Gate.
- Visitors are to be treated with due respect and necessary pass / ID and Helmet to be issued after due verification and the concerned host also to be intimated about the visitor.
- All materials entries are to be made in the respective materials register and proper stamp
  to be endorsed on the invoice / Bill/DC and also should ensure that the duty supervisor
  who ever is on duty to be cross checked and signed over the documents.
- Labour strength report to be submitted to HR / GM
- All the contractor's WC policies are to be maintained live and to be checked before permit
  the labours to enter inside the factory premises.
- All the vehicles coming for work inside the factory to be allowed duly verified the documents like RC, Insurance, Driver's license, etc, and a copy of the same to be retained at gate for record purpose.
- If any new contractors coming for work are to be get clearance from HR for WC policy and PF etc..
- The SO is also responsible for maintaining of all registers
- The above said all the registers are to be checked every day and signed over that.
- To be ensured that proper record to be maintained for hiring vehicles like KM reading in and out timings etc.
- Muster of Security Guards to be carried out every day during morning and evening and also to be briefed during the muster about their duties and responsibilities of the post and deployed in the designated post. Also to be more cautious on vulnerable areas with adequate precautions.

- Attendance for security personnel to be maintained and monthly bills also to be verified and cross checked prior to submission to HR.
- Every month a shift schedule for all Duty SOs are to be forwarded to time office during the last week of the previous month.
- A register for monthly expenditure for Security (Bill), Hired vehicles (Monthly and non-regular) Bills, Two wheeler, Buses Maintenance, etc to be maintained separately.
- Vehicles Bills (Monthly and Non regular) to be verified and cross checked to be submitted to SO for further necessary action.
- Responsible for creating PR in SAP for Vehicles contract, Security contract and all other requirements arises for PR as and when required and also have to make service Entry in SAP for the monthly Bills submitting by the above said contractors.
- The Duty SO has to go for checking the Security Guards twice in a day and general checking of compound wall at least once in a day. Frequent night rounds also to be carried out in and around the compound wall.

Due to this CITPL faced export/import container trucks jammed for hours. My Initiative was surveying and planning to overcome this so I bought concrete blocks and used good out of used wire ropes. Traffic has come under control.
