Topic: "ASSESSMENT OF ADVERSE DRUG REACTIONS ON ANTINEOPLASTIC AGNETS: A PROSPECTIVE OBSERVATIONAL STUDY ON CANCER PATIENTS"

Description: The study population consists of 150 patients in total. From the study it may be concluded that chemotherapeutic index and dosage needed to achieve a therapeutic response usually proves toxic to the body's rapidly proliferating cells. Early modifications in dosage regimen of chemotherapeutic agents may minimize hazardous ADRs..From the study it may be concluded that According to the ADR probability assessment scale, stage wise distribution is highly correlated with the adverse drug reactions.
